31. august 2021	<p>Maritech offers two new services to its customers, and such services are incorporated as additional appendices: Appendix 7 SaaS Agreement and Appendix 8 AMS Agreement. Appendix 7 SaaS Agreement is a new business model based on the Software-as-a-Service concept where the Customer pays a SaaS License subscription and receives the right to use the SaaS Cloud Services, as defined on Maritech's product website. The SaaS Cloud Services includes standard support, maintenance and SLA for the covered Products. Appendix 8 AMS Agreement concerns Maritech's Application Management Services (AMS). AMS applies for on premise as well as SaaS-services delivered on standard Maritech products. AMS includes support on phone, web and e-mail with a guaranteed response time. The customer may purchase Extended AMS. The general terms have been updated to reflect the new Appendices 7 and 8. Definition of contact information and Products are clarified since the information is updated on Maritech's web site. Additional section 2.4 to the general text clarifies which appendices apply between the Customer and Maritech. Definition of call-off clarified: Added the option of special terms for call off agreements, and such special terms will prevail. Appendix 2 EULA updated to reflect the new services SaaS services and AMS. Appendix 6 renamed to Cloud Account Services Agreement. Appendix 6 pertains to cloud services where the Customer gets a personal login to a secure server through a cloud account. Appendix 9 Data Processor Agreement contains Maritech's updated Data Processor Agreement, which details how Maritech handles the processing of Customers' personal data. As well as providing Maritech the necessary legal basis for such processing. The updated DPA reflects the developments in data protection in the EU/EEA following the GDPR entering into force. We have updated the terminology a throughout the Framework Agreement and its appendices to harmonise it throughout the Agreement, and to ensure that that terminology is in keeping with the evolution in cloud based services since 2018.
